## **CPMS-based care pathways in ERN-RND**

## Disease Group specific consultations & best practice

Cases with focus on diagnosis or disease management, clustered by the 6 ERN-RND disease groups:

- Ataxia & HSP
- Atypical Parkinsonian syndromes (MSA, PSP, genetic Parkinson's disease)
- Chorea & Huntington's disease
- Dystonia, NBIA, Paroxysmal Disorders

Cases are discussed in "Case Discussion *jour fixe*" four times per year per group.





#### Neuroradiology advice panels

Standard pathway for receiving a (diagnostic) second opinion by neuroradiology experts on imaging findings of patients with rare neurological disease beyond & across Disease Groups.

#### **MLD Treatment Eligibility Panel**

Not all MLD patients benefit from gene therapy or stem cell transplantation. In collaboration with MLDi, a consensus-based treatment recommendation is provided by this multidisciplinary expert panel.

#### **DBS** for Dystonia

Homogenization of a highly specialised, invasive treatment: multidisciplinary board offering advice for European physicians for dystonia cases pre and post Deep Brain Stimulation.

#### **Krabbe Treatment Eligibility Panel**

High-risk, low evidence: European physicians may consult this panel for advice if or when to offer stem cell transplantation for their patient with Krabbe disease.
